REPRESENTATIONS, WARRANTIES, PROMISES & AGREEMENTS

1. Representations by Applicant. In order to induce the extensions of credit requested on the first page of this application, the applicant warrants that the information given in this application is correct and agrees that the information is material to granting credit. The applicant agrees to advise the companies to which the applicant is addressed, by sending them a notice in writing to 2945 Whittington Avenue, Baltimore, Maryland 21230, of any material change in the information set forth or furnishing herewith.
2. Authority To Verify Information. The applicant authorizes the representatives of any of the companies to which the applicant is addressed to contact any of the references given on the first page of this application and further authorizes each of those references to disclose to any of the companies to which the applicant is addressed any and all information the reference may have relating to the applicant.
3. No Obligation To Extend Credit. The execution of this application does not obligate any of the companies to which it is addressed to sell any goods to the applicant. The decision to extend credit or sell goods to the applicant will be made by the companies to which the application is addressed after reviewing this application and making whatever independent investigation of the applicant's credit history is felt necessary.
4. Capacity To Make Application. If the applicant is a corporation, the person signing this application on behalf of the applicant warrants that he authorized to do so.
5. Individual Liability If Applicant Incorporates. If the applicant is not a corporation at the time of this application, and subsequently incorporates, with or without our knowledge of the companies to which the application is addressed, the applicant agrees to be liable to any of the companies to which the application is addressed for any indebtedness incurred by or transferred to such corporation.
6. Damages. The companies to which the application is addressed shall not be liable for any consequential damages, damages to property, damages for loss of use, loss of time, loss of profit or income or any other incidental damages resulting from late delivery of parts or equipment ordered by the applicant or their failure to render promised services in a timely and efficient manner.

11. Waiver Of Jury Trial. Applicant hereby waives the right to trial by jury in any proceedings brought by or against the companies arising under the terms of or in reference to this agreement.
